RESOLVED, as this Body hereby resolves, to adopt and approve the Joint Committee Report No. 385-2010 dated April 29, 2010 of the Committee on Rules and Revision of Ordinances, Committee on Appropriation and Finance and Committee on Barangay Affairs recommending for the passage of the following proposed resolutions:

- 1) Resolution declaring to be in order and operative Appropriation Ordinance No. 10-01 embodying the FY-2010 Annual Barangay Budget of Sicayab, Dipolog City with the total appropriation of Three Million One Hundred Seventy Seven Thousand Two Hundred Five Pesos and Twenty Seven

Centavos (Php3,177,205.27) with the advice to provide the amount equivalent to one percent (1%) from the Internal Revenue Allotment (IRA) of the Barangay for the strengthening of the Local Council for the Protection of Children in accordance with Republic Act 9344.

- 2) Resolution declaring to be in order and operative Appropriation Ordinance No. 01-10 series of 2010, embodying the FY-2010 Annual Barangay Budget of Barra, Dipolog City with the total appropriation of Two Million Two Hundred Forty Two Thousand Six Hundred Four Pesos (Php2,242,604.00).
