The BAC will use non-discretionary pass/fail criteria in the Eligibility Check/Screening as well as the Preliminary Examination of Bids. The BAC will conduct post-qualification of the lowest calculated bid.

The BAC will issue Bidding Documents only to bidders declared by the BAC to be eligible for the bidding upon payment of a non-refundable amount of =P=1,948,910.30 to the Municipal Treasurer/Cashier.

The bidders shall drop their duly accomplished eligibility requirements, technical and financial proposals in two (2) separate envelopes in the bid box located at the above-mentioned address. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB Clause 18. Bid opening shall be on the date indicated above at the Sangguniang Bayan Session Hall, Municipal Hall, LGU, Piñan, Z.N. Bids will be opened in the presence of the bidder's representatives who choose to attend "LATE BIDS SHALL NOT BE ACCEPTED". They may also obtain the results of the Eligibility Check by the BAC at the same address.

The LOCAL GOVERNMENT UNIT further reserves the right to accept or reject any and all bids, to annul the bidding process and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
